CONSIDERANDO QUE, na reunião de Diretoria realizada em 6 de outubro de 2014, foi aprovada a realização da emissão das 28ª e 29ª séries da 1ª emissão de certificados de recebíveis do agronegócio da Emissora ("CRA"), composta por 1 (um) certificado de recebíveis do agronegócio subordinado, da 29ª série da 1ª emissão da Emissora ("CRA Subordinado") e por 237 (duzentos e trinta e sete) certificados de recebíveis do agronegócio seniores, da 28ª série da 1ª emissão da Emissora ("CRA Sênior" e, em conjunto com os CRA Subordinado, os "CRA"), todos nominativos e escriturais, sendo os CRA Sênior com valor nominal unitário de R\$312.500,00 (trezentos e doze mil e quinhentos reais) e os CRA Subordinado com valor nominal unitário R\$26.235.792,97 (vinte e seis milhões duzentos e trinta e cinco mil e setecentos e noventa e dois reais e noventa e sete centavos, perfazendo, na data de emissão, qual seja 11 de fevereiro de 2015 R\$100.298.292,97 (cem milhões duzentos e noventa e oito mil duzentos e noventa dois reais e noventa e sete centavos) ("Emissão");

CONSIDERANDO QUE, em 26 de janeiro de 2015, as Partes firmaram o "Termo de Securitização de Créditos do Agronegócio das , 28ª e 29ª Séries da 1ª Emissão de Certificados de Recebíveis do Agronegócio da Octante Securitizadora S.A." ("Termo de Securitização");



CONSIDERANDO QUE o Anexo I do Termo de Securitização fornece a descrição dos créditos do agronegócio

CONSIDERANDO QUE as Partes desejam retificar a lista do Anexo I do Termo de Securitização;

CONSIDERANDO QUE, nos termos do item 14.12 do Termo de Securitização, o Termo de Securitização poderá ser alterado ou aditado independentemente de Assembleia de Titulares de CRA, desde que as mesmas decorram de ajustes formais aos procedimentos da Emissão, inclusive da necessidade de vincular os novos Lastros e as novas Garantias à definição de Lastros e Garantias, respectivamente, bem como ao Patrimônio Separado, tendo em vista a instituição do Regime Fiduciário;
